

5 years GUARANTEE on

STAZO® *marine equipment b.v. in the Netherlands* provides a 5 years guarantee on all MARINEDECK®*exterior* planks, strips, plates or pre-fabricated decks provided that:

1. The deck has not been subject to abuse, neglect, accident or to improper installation.
2. The deck has not been subject to another use as it is officially meant for.
3. The deck has not been repaired or altered
4. The owner has the original invoice showing the date of purchase and a specification of the purchased MARINEDECK®*exterior* products.
5. The pre-fabricated deck is manufactured by STAZO® *marine equipment b.v. in the Netherlands*

Conditions of guarantee:

A. STAZO® *marine equipment b.v. in the Netherlands* warrants each MARINEDECK®*exterior* plank, strip, plate or pre-fabricated deck for a period of 5 years from the original date of purchase, to be free from any defects. The applied SIMSON installation materials are explicitly excluded from the STAZO® warranty (please see below). The guarantee ends 5 years after the original date of purchase.

B. Without charge to the customer STAZO® *marine equipment b.v. in the Netherlands* will replace any MARINEDECK®*exterior* planks, strips, plates or pre-fabricated decks found to be defective within the period of guarantee. Cost of labor concerning any removal or re-installation MARINEDECK®*exterior* planks, strips, plates or pre-fabricated decks is excluded from guarantee.

C. STAZO® *marine equipment b.v. in the Netherlands* assumes no responsibility for the cost of the removal of the product or any other incidental costs which may arise as the result of defect in materials.

D. STAZO® *marine equipment b.v. in the Netherlands* will not be liable for any consequential damages or amount in excess of the purchase price of such damaged MARINEDECK®*exterior* plank, strip, plate or pre-fabricated deck, whether due to the use or installation of the product.

E. Any applied binder to make invisible butt joints is explicitly excluded from any guarantee, incl. the prescribed binder.

F. Compensation will never exceed the actual buying price at the moment of purchase.

G. The guarantee is not transferable.

H. No person or other company, other than STAZO® *marine equipment b.v. in the Netherlands*, STAZO® *marine equipment Australasia Pty. Ltd.* in Western Australia, or STAZO *marine equipment (NA) Inc.* in the USA, is authorized to give any other guarantee or warranty or to assume any other liability in connection with (the sale of) the concerning MARINEDECK®*exterior* planks, strips, plates or pre-fabricated decks, as being specified in these present conditions of guarantee.

I. Warranty is not applicable if detachments or other defects in the work, carried out occur as a consequence of a faulty building structure, an inferior substrate, inferior workmanship or the application of loads that exceed the potential of the products capacity, or that occur while STAZO® or customers of STAZO® have not complied with these directions, or have followed different directions in connection with the work carried out or the use of the products, processed or otherwise, such as included in the TDS, Product Descriptions and Application Guides or as shown on any of the concerning web sites.

Important notes: Any applied coating whether delivered by STAZO® *marine equipment b.v. in the Netherlands* any other third party is explicitly excluded from any guarantee or warranty.

Limited guarantee of 5 years on any prescribed SIMSON marine products for the installation of MARINEDECK 2000®*EXTERIOR* : STAZO® *marine equipment b.v. in the Netherlands* accepts no responsibility whatsoever for any of the prescribed SIMSON materials. The 5 years limited guarantee on SIMSON materials is provided by Bostik b.v. in the Netherlands in accordance to their terms of limited guarantee and for a period of 5 years after the actual date of purchase. The guarantee is to be reduced by 20% per year after the installation. Compensation will never exceed the actual buying price at the moment of purchase. Extended and specific conditions of warranties can be obtained from Bostik b.v. in the Netherlands. The SIMSON warranty will not apply if it is found that harsh cleaners, having an Alkali reading of greater than pH 8 and an acid reading less than pH 4,5, were used in areas where any SIMSON products are located.
